End-of-Month Close

The Month-End Close is an accounting procedure that ensures all financial transactions have been accounted for in the previous month. To ensure that they are reported accurately, accounting teams need to review, verify, and reconcile all records each month.

Recognizing that each company has its own procedures for closing operations, and that Guardian is not an accounting consultant and cannot provide accounting advice, this article outlines the Guardian reports (and where to find them) commonly used by our Guardian clients. *Guardian recommends consultation with your CPA to determine the best procedure and reports to meet your specific requirements.* Not all Guardian clients use all the reports listed.
